#### FLOOR TO MEMBERS OF THE PUBLIC

Roseanne D'Angelo, 383 Mount Prospect Ave., spoke about water damage in her home due to the road pitching in the wrong direction.

Cameron Hebron, 61 George Russell Way, discussed a hate message which was graffitied on an overpass on Allwood Road.

Joseph Czarnecki, 56 William St., spoke about speeding and using stop signs as a deterrent, oversize trucks on streets with weight limits and school busses riding through residential areas.

Bart Ciervo, 306 Delawanna Ave., inquired about erecting a dog park, installing "curb your dog" signs and placing garbage pails in Dunney Park. He asked if any local hotels were housing illegal immigrants.

Gary Perino, 491 Mount Prospect Ave., discussed curbs and sidewalks on Mount Prospect Ave. and letter that he sent to the City Manager regarding the establishment of a City museum.

Joseph Holzli, 75 Mountainside Terrace, spoke about flooding during Hurricane Ida at Firehouse #1, Pearl Brook and the Clifton Senior Horizons complex.

A Motion was made by Councilwoman Sadrakula, seconded by Councilman Latona and passed on roll call vote to close the public session.

(5-0-0-2) Councilman Kolodziej, Councilman Latona, Councilwoman Pino, Councilwoman Sadrakula and Mayor Grabowski voted aye. Councilman Gibson and Councilwoman Murphy were absent.

City Manager, Dominick Villano, addressed the flooding issue on Mt. Prospect Avenue. He spoke about a prior plan by Passaic County to address the flooding issue but was not approved by the prior Council. He stated a request was put in to have the County redesign the project and resubmit it for Council approval.

City Manager, Dominick Villano, discussed the derogatory graffiti on Allwood Road. He remarked that the DOT was informed that the City DPW would be removing the graffiti immediately. He said the issue was reported to the FBI and the State Police and the State Police have taken over the investigation to find the offender.

City Manager, Dominick Villano, responded to Mr. Czarnecki and reported that the City cannot use stop sings to control traffic. Mr. Villano remarked that he would have police set up radar and check on the weight limit of the trucks using the roadway.

City Manager, Dominick Villano, responded to Mr. Ciervo and reported that the Recreation Department is in the process of polling the neighborhood to see if the majority is in favor of installing a Dog Park in Dunney Park. He remarked that garbage pails were ordered for the park. Mr. Villano stated that he spoke to motel managers in the area and none are housing refugees.

City Manager, Dominick Villano, responded to Mr. Perino and stated that the space in the newly renovated barn on City Hall property is needed for office space and suggested a committee be formed to find a different property for a museum.

City Manager, Dominick Villano, asked Mr. Holzli to make an appointment to come to his office and he will discuss the Ida flooding with him.

#### CITY MANAGER PRIVILEGE/RESPONSE TO RESIDENTS

City Manager, Dominick Villano, announced that several residents of Hadley Avenue, that were flooded from Ida, have qualified for Blue Acres assistance.

#### **COUNCIL PRIVILEGE**

#### **Councilwoman Murphy**

Councilwoman Murphy was absent.

#### **Councilwoman Pino**

Councilwoman Pino asked Administration to send a letter to Paterson regarding the unclean condition of their side of Crooks Avenue. She expressed her displeasure regarding the memo that the Legal Department put on the agenda regarding murals advising that the person who could answer questions regarding their mural Ordinance was on vacation. She also expressed her displeasure that Administration was providing "red tape and excuses" regarding installing a dog park in Dunney Park. She remarked that she agreed with the idea of a museum and enforcing the sidewalk ordinance. Councilwoman Pino spoke about a recent group clean-up of Dundee Park. She announced that the Beautification Committee met and they are working on organizing more public clean-up events. Councilwoman Pino announced a fundraiser being held by School Four.

#### Councilwoman Sadrakula

A Motion was made by Councilwoman Sadrakula, seconded by Councilman Latona, and passed on roll call vote to place a discussion item on the next Council agenda to set up a committee to establish a City museum.

(5-0-0-2) Councilman Kolodziej, Councilman Latona, Councilwoman Pino, Councilwoman Sadrakula and Mayor Grabowski voted aye. Councilman Gibson and Councilwoman Murphy were absent.

A Motion was made by Councilwoman Sadrakula, seconded by Councilman Latona and passed on roll call vote to place an item on the next Council agenda to discuss the City Council meetings taking precedence over any other board meeting when it comes to being televised.

(5-0-0-2) Councilman Kolodziej, Councilman Latona, Councilwoman Pino, Councilwoman Sadrakula and Mayor Grabowski voted aye. Councilman Gibson and Councilwoman Murphy were absent.

Councilwoman Sadrakula asked that the County be put on notice regarding flooding on Mount Prospect Ave. She spoke about the recently discovered bigoted graffiti on Allwood Road, using speed tables, the flooding at Firehouse #1, city wide flooding and enforcing the sidewalk ordinance. Councilwoman Sadrakula discussed the importance of being consistent and transparent.

#### Councilman Kolodziej

Councilman Kolodziej discussed the need for consistency and stated that many problems arise from trying to keep taxes as low as possible. He expressed his discontentment about bigoted graffiti and social network posts. He suggested that the vote for the Cap Bank Ordinance be sent to the State. Councilman Kolodziej remarked that the idea of redevelopment projects getting preferential treatment is false. He stated that apartment buildings and commercial developments are a significant contributor to City taxes. He spoke about the budgeting process and the need to raise taxes to keep providing the needed services. Councilman Kolodziej spoke about many promises being made by Council members that become "lip service" if there is no funding available.

#### Councilman Latona

Councilman Latona announced various events taking place around the City. He congratulated recipients of awards from the Eagle Scouts and the Knights of Columbus. Councilman Latona discussed newly paved roads and utility digging, the process for hiring in the City and rabies shots provided by the Health Department.

A Motion was made by Councilman Latona, seconded by Councilwoman Pino and passed on roll call vote to add a discussion item on the next Council agenda to come up with a "not to exceed amount for professional services" that will compel the item to be brought before Council prior to acceptance if the quote is over the "not to exceed amount".

He spoke about flooding on Mount Prospect Ave., general funds for parks and development and infrastructure accountability. He asked for an update of the Pearl Brook flood report. Councilman Latona wished everyone a Happy Father's Day.

#### **Councilman Gibson**

Councilman Gibson was absent.

#### Mayor Grabowski

Mayor Grabowski spoke about Clifton being a highly diverse community and that bigotry in any form will not be tolerated. He explained how the removal of recent hate graffiti on Allwood Road

was handled. Mayor Grabowski spoke about the importance of line striping at stop signs. He explained the process of how items get put on the agenda. Mayor Grabowski urged all residents to try to stay indoors to avoid the heavy smoke the Northeast is experiencing due to Canadian wildfires.

Council returned to Workshop Session.

## RESOLUTION AWARDING CONTRACT TO DE COTIIS, FITZ PATRICK, COLE & GIBLIN, LLP FOR LABOR COUNSEL SERVICES FOR THE TERM MARCH 1, 2023 THRU FEBRUARY 28, 2024

**WHEREAS**, the City of Clifton requires the services of Labor Counsel to perform certain legal services for the City of Clifton; and

WHEREAS, in response to request for proposals, five proposals were received including a proposal from, DeCotiis, FitzPatrick, Cole & Giblin LLP dated March 14, 2023; and

WHEREAS, after reviewing the proposal and upon the recommendation of the Mayor and Council, the Municipal Council wishes to award a contract to DeCotiis, FitzPatrick, Cole & Giblin LLP for a period of one year commencing March 1, 2023 and ending February 28 2024, at a fee of \$175/hr for partners and \$150/hr for associates, not to exceed \$90,000 for the term of the contract for the provision of said services; and

**WHEREAS**, such services constitute "Professional Services" with the ambit of N.J.S.A. 40A:11-5 and also based upon price and other factors considered, the Council wishes to award the contract to DeCotiis, FitzPatrick, Cole & Giblin LLP whose proposal is most advantageous to the City; and

WHEREAS, any fee in excess of \$90,000 for the contract term shall require the approval of the Municipal Council and the adoption of a supplementary resolution; and

**WHEREAS**, the services to be performed are professional and/or extraordinary unspecifiable services, within the meaning of those terms as used in the Local Public Contracts Law, *N.J.S.A.* 40A:11-1 *et seq.*, and, accordingly, a contract may be awarded therefor without public advertising for bids and bidding in accordance with *N.J.S.A.* 40A:11-5; and

**WHEREAS**, the award is of a non-fair and open contract in accordance with *N.J.S.A* 19:44-A-20.5; and

WHEREAS, the estimated value of the contract is expected to be in excess of \$17,500.00, and the duration of the contract is until the services are completed; and

WHEREAS, the Business Entity Disclosure Certification has been received from counsel and is incorporated in the contract awarded hereby, along with the Determination of Value; and

**WHEREAS**, there are funds available for the payment of the aforesaid services and the Chief Financial Officer has endorsed a Certification of Funds hereon;
