(Clifton) - The Clifton Health Department, in consultation with the City Manager, Mayor and Council, understands that residents are concerned about the Coronavirus (COVID-19) pandemic.

The City of Clifton has had **123 NEW COVID-19 cases since last Friday, 9/17**, bringing the total COVID-19 case count to **12,900**. **Upon further investigation, 3 cases were transferred out and 3 cases were found to be duplicates of existing cases; these cases have been removed from the total spreadsheet count, and have resulted in a slightly decreased number of OVERALL cases.**

With a heavy heart, we are reporting two additional COVID-19-related deaths involving one 87-year old male and one 42-year old male that occurred within the last week. Our sincerest condolences go out to the loved ones of these community members.

The City of Clifton has a total of 288 deaths.

Of these deaths, 45 have involved residents at the Daughters of Miriam Nursing Home. Please be advised that this number is reflective of the deaths identified in the Communicable Disease Reporting and Surveillance System.

The City of Clifton has administered the following COVID-19 vaccine doses between January, 6, 2021 and September 23, 2021:

1st doses	8,161
2nd doses	7,105
3rd doses	41
Total number of doses	15,307

Currently, the Clifton Health Department ONLY administers the Moderna vaccine.

The Clifton Health Department Does NOT administer the Pfizer-BioNTech COVID-19 vaccine.

As Per the CDC's Statement on ACIP Booster Recommendations on September 24th, 2021. The CDC recommends:

- people 65 years and older and residents in long-term care settings, should receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series.
- people aged 50–64 years with underlying medical conditions should receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series.
- people aged 18–49 years with underlying medical conditions may receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series, based on their individual benefits and risks, and
- people aged 18-64 years who are at increased risk for COVID-19 exposure and transmission because of occupational or institutional setting may receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series, based on their individual benefits and risks.

CDC will continue to monitor the safety and effectiveness of COVID-19 vaccines to ensure appropriate recommendations to keep all Americans safe.

The CDC will also evaluate with similar urgency available data in the coming weeks to swiftly make additional recommendations for other populations or people who got the Moderna or Johnson & Johnson vaccines.

Guidance on booster doses for the general public is forthcoming from the CDC and the New Jersey Department of Health. Once we have this information, we will keep the community informed about how to receive the booster shot.

As per Executive Order 253 signed by Governor Murphy on 8/23, all state employees – including those at state agencies, authorities, and public colleges and universities – are required to complete a full vaccination course or undergo regular testing at a minimum of once to twice each week. Additionally, all preschool-through-grade 12 school personnel are required to complete a full vaccination course or undergo regular testing at a minimum of once to twice each week.

Full compliance is required by October 18th.

The Clifton Health Department is now holding clinics for third doses of the Moderna vaccine every Wednesday from 9am-11am. Appointments for third dose clinics are

REQUIRED, and can be made by calling the COVID-19 hotline at 973-470-2039. A representative of the Clifton Health Department will return your call to ask a series of questions to confirm eligibility to receive a third dose, and make the appointment for you.

At this time, these clinics are open to immunocompromised individuals ONLY. Please note that these doses are NOT booster doses, and are NOT available for the general population at this time.

In accordance with the New Jersey Department of Health and CDC's guidelines, those currently eligible for third doses include:

- **Individuals who have been receiving active cancer treatment for tumors or cancers of the blood**
- **Individuals with advanced or untreated HIV infection**
- **Individuals undergoing active treatment with high-dose corticosteroids or other drugs that may suppress immune response**
- **Individuals who have received an organ transplant and are taking medicine to suppress the immune system**
- **Individuals who have received a stem cell transplant within the last 2 years or are taking medicine to suppress the immune system**
- **Individuals with moderate or severe primary immunodeficiency (such as DiGeorge syndrome, Wiskott-Aldrich syndrome)**

The Clifton Health Department continues to hold weekly vaccination clinics for first and second doses of the Moderna vaccine at Clifton City Hall, across from Parking Lot #4, on Wednesdays at 9am-11am. Appointments are not necessary. For more information, please call 973-470-2039.

Cases have been increasing in the City of Clifton, as well as across the state and country. The Health Department urges residents to be vigilant, and take the steps necessary to protect themselves and loved ones. Get vaccinated if you have not already, wear a mask indoors, especially where there is an increased risk of transmitting the virus, and take other preventative steps to protect yourself and loved ones from this virus.

As per Governor Murphy's announcement on 8/6/2021, all students, educators, staff, and visitors will be required to wear masks inside of school buildings – regardless of vaccination status – for the start of the 2021-2022 academic year.

Governor Murphy and the New Jersey Department of Health strongly recommend that BOTH vaccinated and unvaccinated residents wear masks in indoor settings when there is

increased risk.

Examples of increased risk situations where masks are recommended include:

- **Crowded indoor settings**
- **Indoor settings involving activities with close contact with others who may not be fully vaccinated**
- **Indoor settings where the vaccine status of other individuals in the setting is unknown**
- **Where an individual is immunocompromised or at increased risk for severe disease**

Effective Friday, June 4, 2021, indoor gathering limits have been removed. The New Jersey Department of Health reminds us that COVID-19 remains a threat, particularly at indoor gatherings with unvaccinated individuals, and encourages us to follow the safety tips described in this article: <https://covid19.nj.gov/faqs/nj-information/reopening-guidance-and-restrictions/how-can-people-safely-get-together-what-are-the-limits-for-indoor-and-outdoor-gatherings>

There are no capacity limits for outdoor gatherings or outdoor performances.

Face masks are still required for all individuals on public transportation, health care facilities, including nursing homes and office-based health care settings, child care centers, K-12 schools, summer camps, homeless shelters, and correctional facilities, which remain subject to existing requirements and/or recommendations.

In addition, businesses may continue to require face coverings for employees, customers, and guests. Businesses are not permitted to restrict the use of face masks by their staff, customers, or visitors.

Indoor worksites not open to the public, such as commercial office spaces and manufacturing and warehousing facilities must continue following existing health and safety protocols for employers including mask mandates. Masks will continue to be required in State offices, including public offices such as Motor Vehicle Commission agencies.

Effective 5/19, the outdoor mask mandate has been lifted, although unvaccinated individuals should continue to exercise caution.

Effective 5/19, the travel advisory has been lifted.

With regards to **domestic travel**, New Jersey residents returning home and travelers visiting New Jersey do not need to quarantine, but should follow travel guidance from the CDC, the NJ Department of Health, and all local health and safety protocols of their travel destination. The CDC continues to recommend delaying travel until you are fully vaccinated. The CDC also currently recommends that unvaccinated individuals traveling domestically get tested 1-3 days before their trip, 3-5 days after travel, and stay home and quarantine for 7 days after travel, even with a negative test. If no test is taken, a 10-day quarantine is recommended. Travelers should continue to wear masks and monitor for symptoms. With regards to **international travel**, the CDC requires all air passengers arriving in the United States from a foreign country to get tested for COVID-19 no more than 3 days before their flight departs and to present the negative result or documentation of having recovered from COVID-19 to the airline before boarding the flight. The CDC continues to recommend delaying travel until you are fully vaccinated. The CDC also currently recommends that unvaccinated individuals traveling internationally get tested 1-3 days before their trip, 3-5 days after travel, and stay home and self-quarantine for 7 full days after travel, even if you test negative. If no test is taken, a 10-day quarantine is recommended. Travelers should continue to wear masks and monitor for symptoms. Everyone who lives, works or studies in New Jersey, ages 12+, is now eligible to be vaccinated. Currently, ONLY the Pfizer vaccine is authorized for individuals 12-17. Please remember that minors must be accompanied by an adult and have parent/guardian consent.

Due to a high volume of total cases, the “follow-up status” column on our spreadsheet attachments has been removed. We will still provide information on which cases are asymptomatic and those that are deceased.

You will notice that many of the boxes in the case information attachment are labeled “under investigation.” We are still in the process of following-up with individuals and obtaining this data. We will continue to update this spreadsheet as this information becomes available.

It is very important to remember the following preventative steps you can take to reduce the risk of spreading COVID-19:

Practice handwashing regularly for at least 20 seconds

- Cover your cough and sneeze with a tissue
- Avoid touching your eyes, nose, and mouth
- Clean and disinfect frequently touched objects and surfaces

In addition, be sure to practice the following social distancing measures, if you are not vaccinated:

- Keep a distance of at least 6 feet with other people
- Avoid unnecessary physical contact, such as handshaking
- Avoid attending crowded events and social gatherings

As a reminder to residents, if you are being tested, remain home while awaiting your results, whether or not you're showing symptoms, to avoid potentially infecting other people.

In the attachment, you will notice that we have included ALL cases we have received so far, including Little Falls cases and transferred cases. This does not change the current total case count, and it is being done for our convenience in order to better track our cases.

If you receive a call from the Clifton Health Department for case follow-up, there are specific questions we would ask. We would **never** ask for your social security number, so if you receive a call from anyone claiming to be a representative of the Clifton Health Department who asks for your social security number, please hang up immediately and report it to the Police Department at 973-470-5911.

Please note: the Health Department does not have the capacity to distribute masks, sanitizers, and other supplies to the public.

The CDC has recently expanded its list of COVID-19 symptoms to include the following:

- Fever
- Cough
- Shortness of breath or difficulty breathing
- Chills
- Repeated shaking with chills
- Muscle pain
- Headache
- Sore throat
- New loss of taste or smell

Some people who are exposed may show mild symptoms, while others may show severe illness. Remember that symptoms can appear **anywhere from 2-14 days after an exposure.**
