RECYCLING REPORT DUE FRIDAY, MARCH 17, 2017

To meet the New Jersey Statewide Mandatory Source Separation and Recycling Laws, all businesses and institutions are required to separate, recycle, and document any of the following materials listed on the back of this sheet.

It is the responsibility of each establishment to ensure that a recycling system is in place, and that all recyclables are reported to the city each year. You may choose to have your recyclables collected by a solid waste hauler, a recycling collection firm, or the city's municipal collection program. Some establishments may prefer to take them to the city drop-off center.

If you utilize a private hauling company, you are responsible for separating recyclable materials and keeping them out of all containers holding non-recyclable trash. Your hauler must provide you with sufficient containers for recyclable materials and must submit to you proper documentation to meet state requirements. **Proper documentation must consist of:**

- 1) All materials recycled in 2016.**
- 2) A letter of verification on your company letterhead is acceptable, and/or fill out and sign the back of this form.**
- 3) Total weight / tonnage of each type of material recycled (see list of materials on other side of letter).**
- 4) Recycling company and location of where material was recycled.**

Documentation MUST be submitted no later than Friday, March 17, 2017. Please mail all documentation to:

If your materials are collected by the City's recycling pickup or you bring recyclables to the Recycling Center you must call the Recycling Office to report your information, and submit letter with recycling data.

Any establishment not complying with the local recycling and reporting requirements may be subject to a fine not to exceed **One Thousand Dollars (\$1,000.00)**
